Gerry Murray (Chair of the Board) took the chair in accordance with Rule C28 and confirmed that a quorum was present (Rule C24) there being 31 Members attending in person or by proxy.

## 2. Minutes of Annual General Meeting held on 21<sup>st</sup> October 2019

Gerry noted that the minutes of the previous Annual General Meeting held on 21st October 2019 had been published on NCLT's website. Following a proposal from Clyde Whittaker, seconded by Paul Mansbridge, the minutes were unanimously APPROVED. No matters arising were raised.

#### 3. Annual Report and 2019 Accounts

- On behalf of the Board, Gerry Murray presented the Annual Report, NCLT's audited accounts for its first financial year between 1st April 2019 (the date of incorporation) to 31st December 2019 and the report of the Auditors on the accounts, noting that these documents had been published on NCLT's website. Income in the period ending 31st December 2019 had been £9,746 from donations and two grants from Wiltshire County Council and the National CLT Network respectively. Expenditure of £5.046 had been directed at the cost of incorporation, including legal fees, website/printing and community engagement activities, which had enabled NCLT to achieve a membership of 261 by year-end.
- Gerry then updated members on work in 2020 to date. The Covid emergency had led to a difficult environment for much of the year, and the government's planned changes to the planning system, with its emphasis on national policy-making, may potentially frustrate local communities wishing to progress their own vision for the shape of





development based on their local circumstances and to progress community-led projects in their areas. More optimistically, government funding for affordable housing projects appeared likely to continue and a genuine opportunity had emerged which might enable provision of affordable homes in Tisbury through a community-led development, supported by Wiltshire Council and Tisbury Parish Council. The Board and Steering Group will continue to work on this over the coming months with the aim of bringing forward a proposal for wider community engagement.

- Following a proposal from Gerry Murray, seconded by lone Lacey it was RESOLVED unanimously to receive the Annual Report, Annual Accounts and Auditors Report in accordance with Rule C18.
- Gerry thanked all those volunteers who had supported NCLT's work during its first year, in particular Tony Deane, NCLT's first Chair and those who had served on the Board and Steering Group.

#### 4. 2020 Audit Arrangements

On behalf of the Board, Gerry Murray introduced the proposed resolution to disapply Section 83 of the Co-operative and Community Benefit Societies Act 2014 in respect of NCLT's accounts for the year ending 31st December 2020 as shown on the agenda paper. This permits Nadder Community Land Trust's records of account to be examined at less cost by an independent examiner for the year-ending December 2020 in view of the limited number of transactions which have taken place. At Gerry's recommendation the proposed resolution was put to a ballot, and was passed with 31 votes in favour, nil against and no abstentions.
